**GDPR Declaration
under the (EU) Regulation no. 679/2016**

I, the undersigned _____, domiciled in _____ having Personal Identification Number _____ declare that, in accordance with the requirements of the (EU) Regulation 679/2016, hereinafter referred to as GDPR, I confirm that I have read and agreed to the terms of „Ștefan cel Mare” University of Suceava, represented by Ph.D. Prof. Eng. Valentin POPA, as Rector, with the registered office in Suceava, Str. Universității, nr. 13, Suceava, e-mail rectorat@usv.ro, Telephone: +40230216147, Tax identification/registration number 4244423, has the legal obligation to process my personal data, by automated/manual means, for the purpose of carrying out the contractual relations concluded by me with the University according to the provisions of Law no. 1/2011 – National Education Act.

Personal data: surname and first name; parents' surname and first name; date and place of birth; residence/address; urban/rural background; personal identification number (CNP); ID card series and number; signature, photo (picture) on ID card and student ID card; telephone number; email address; name of educational institution/unit graduated; diploma series/number; place of employment (if applicable); position/profession (if applicable); the medical data attesting the ability to have the quality of a student from a medical point of view; marital status; name and surname of spouse on marriage certificate (if applicable); ethnic origin (if applicable); religious denomination (if applicable) are obtained by completing and signing the application form for the admission competition and, if applicable, the application for enrolment to study at the „Ștefan cel Mare” University of Suceava, as well as the supporting documents/records attached to them. This information is registered by the University in its database in any material (paper) and electronic form.

I have acknowledged the fact that my personal data concerning my ethnic origin will be processed by the University if I intend to occupy one of the study places reserved for members of that ethnicity, as well as my personal medical data included in the medical reports/certificates.

The purpose of the data collection is the processing of acts/proceedings within the „Ștefan cel Mare” University of Suceava, according to my request, in order to initiate and execute the legal contractual relations between the undersigned and the University and to fulfil the legal obligations incumbent upon the „Ștefan cel Mare” University of Suceava, to administrate, process and transmit my personal data securely, including through the platforms used by the University and other public registers provided for by law and only for the purposes provided for by the legislation in force.

The legal basis for the collection and processing of my personal data for the above-mentioned purpose is: my consent, my application for admission to the entrance examination, my application for enrolment to studies, Law no. 1/2011 - National Education Act, Law no. 16/1996 on National Archives, republished, as amended and supplemented.

At the same time, I have acknowledged that my personal data are transmitted, by any means of communication, to the following recipients: the data subject (the undersigned), public institutions/authorities (e.g. Ministry of Education, ARACIS - The Romanian Agency for Quality Assurance in Higher Education), tax authorities, verification and control authorities, under the conditions established by law, or other entities whose activities are relevant to the activity of „Ștefan cel Mare” University of Suceava or that have a direct or implicit connection with the implementation of the act or procedures for which we have initiated legal relations with the University and that, in turn, are personal data operators.

According to the **Regulation (EU) no. 679/2016**, I acknowledge that I have the following rights: the right to be informed about the processing of my personal data; the right to object to said processing as well as the right to restrict the processing of my personal data, as long as these do not contravene the legal obligations of the University; the right to data portability; the right of access to personal data free of charge; the right to rectification or erasure of personal data ("right to be forgotten"), as long as this does not contravene the legal obligations of the University; the right to withdraw consent at any time, in the specific case where the collection and processing of data is based on consent and there is no contractual or legal provision requiring the collection and processing of data; the right not to be subject to automated individualised decision-making, including the creation of individual profiles; the right to file a complaint with the personal data processing supervisory authority (ANSPDCP) or to go to court regarding the processing of my personal data. I also acknowledge that my personal data will be processed/kept for as long as I am a student at „Ștefan cel Mare” University of Suceava, as well as after this period, in accordance with the legal provisions under which time limits for the processing of such data are regulated, such as, for example, legal provisions governing the archiving of documents or legal provisions governing the activity and functioning of higher education institutions.

I have acknowledged that I am under obligation to provide the data necessary to achieve the above-mentioned purpose and that refusal to provide such data or providing such data incorrectly and/or incompletely makes it impossible for the University to initiate or, as the case may be, to execute and complete the act or procedure, as it would result in non-compliance with specific legal regulations in the field of education.
